BUREAU NEWS

Commissioner Lepor discussed and reviewed meeting notes and financials from meeting for the Bureau of safety. Commissioner Lepor discussed 2 members from each fire board were selected to form committee to discuss and come up with options for funding future retirements.

OLD BUSINESS

- 1. Solar Energy- Other companies may be coming up with proposals.

- 3. Energy Audit-The Board approved to have the free energy audit done by Mardan and Sons.
- 4. Contractors- Marsdan and Sons contract proposal is \$85/hr, electrician's helper \$25/hr, Bucket truck \$100/hr materials 15% above cost. Night and weekend \$100/hr \$35/hr for helper 24hr service. Konopka & Marsdan and sons llc contract proposal is \$80/hr \$25/hr helper, weekend and nights \$100/hr and \$35/hr for helper. On motion by Commissioner Van Mourik and Seconded by Commissioner Robertson with all in favor the Board approved contracts.

NEW BUSINESS

1. Atlanticare Regional Medical Center has presented the Board with a lease agreement to lease a portion of the Firehouse. After a lengthy discussion the following are the highlights of discussions.

Lower Township Rescue Squad supports having Atlanticare as a ALS (non-transport) in the Township.

Monthly lease should be \$1200.

Solicitor Tourison will read proposal and produce a contract with adjustments that were discussed at the meeting.

2. Verizon- Commissioner Van Mourik spoke with Verizon about the land lines and was able to reduce monthly payment by approximately \$66.
