## **BACKGROUND**

WHEREAS, the boiler heating system in the Erma Firehall located at 415 Breakwater Road, Lower Township, New Jersey has failed and requires immediate replacement; and

**WHEREAS**, The Commissioners of Fire District No. 3, in the Township of Lower, County of Cape May, State of New Jersey, do herewith declare that an emergency exists affecting the safety, health and welfare of the public, and recommend that the Fire District engage a contractor to be mobilized to effectuate the replacement of the boiler heating system; and

4. All actions heretofore taken and documents prepared or executed by or on behalf of the Fire District by the members of the Board or by the Fire District's professional advisors, in connection with the award of contract, are hereby ratified, confirmed, approved and adopted, in all respects.

- 5. The Chairman, Vice Chairman, Secretary and Treasurer are each hereby authorized and empowered to enter into a formal contract with GAUDELLI BROS., INC. in accordance with this Resolution.
- 6. Notice of this resolution shall be published in the official newspaper of the Fire District.
