WHEREAS, the contract for the NEW STANDBY GENERATOR, ERMA VOLUNTEER FIRE COMPANY CONTRACT was awarded to MJF ELECTRICAL CONTRACTING, INC.; and

WHEREAS, the project engineer further recommends that the Board of Commissioners release the performance bond, authorize final payment in the amount of \$24,400.00 and accept the submitted maintenance bond.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioner of Fire District No. 3, in the Township of Lower, County of Cape May, State of New Jersey, as follows:

- 1. The above recital paragraphs are incorporated herein as if set forth at length.
- 2. That the plan and design as set forth in the Specifications prepared by Frank Tindall, of Kelter & Gilligo Consulting Engineers, as modified by approved change orders, field modifications and as depicted in the accepted as-built plans for the NEW STANDBY GENERATOR, ERMA VOLUNTEER FIRE COMPANY CONTRACT are hereby approved and accepted.
- 3. That the above improvements performed by MJF ELECTRICAL CONTRACTING, INC. are hereby approved and accepted.

- 4. That Frank Tindall, of Kelter & Gilligo Consulting Engineers is hereby authorized to release the performance bond conditioned upon acceptance of the appropriate maintenance bond.
- 5. That Treasurer is hereby authorized to release the balance of the contact amount of \$24,400.00 to MJF ELECTRICAL CONTRACTING, INC. less any payment of all professional escrow fees, or other valid and proper adjustments, if any.
- 6. This shall take effect immediately upon adoption this 19th day of September 2023.
- 7. Notice of this resolution shall be published in the official newspaper of the Fire District.
